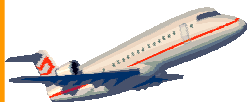

Promotion Rules:

- Promotion is open to all Fully Qualified Supervisors.

- In the event that a qualifier is denied a visa to attend, an alternative reward may be provided, but only at the sole and absolute discretion of Herbalife.
- Distributors who qualify, but do not attend for any reason, forfeit their right to the 2010 Asia Pacific Vacation award.
- Herbalife has the sole and absolute right to determine room assignments.
- You are entitled to one (1) room. A spouse, legal partner, other guest will be eligible to attend with you, however, a Distributor who did not qualify for the Vacation may NOT attend as a guest.
